- C. If the Purchaser defaults against COD terms, Purchaser is liable to pay all costs of collection, including finance charges (at the rate of 1 1/2% per month or 18.0% annual percentage rate), court costs and reasonable attorney fees, whether or not suit is actually filed. Purchaser agrees that any legal action brought hereunder may be brought in Salt Lake County, Utah or Utah County, Utah at the option of GRP, SRC, and/or SPC.
- D. At the sole option of GRP, SRC, and/or SPC, any and all disputes, claims and controversies arising out of any transactions resulting between the parties hereto, shall be subject to and resolved by binding arbitration in accordance with the rules and procedures of the American Arbitration Association.
- E. Construction Lien filing fee is a minimum of \$150.00 for each individual property liened and will be charged to and paid by Purchaser as a cost of collection.
- F. It is the Purchaser's obligation to notify GRP, SRC and/or SPC in writing and by certified mail of any change to any of the information provided by Purchaser in the COD Account Application. Such notification shall be addressed to and received by Geneva Rock Products, Inc. at PO Box 571618, Salt Lake City, Utah 84157; or Sunroc Corporation at PO Box 778, Orem, Utah 84059; or Sunpro Corporation at PO Box 2210, Orem, Utah 84059.
